Delaware Jeep Association Driver Agreement

The undersigned agrees to the following:

- I am at least 18 years of age.
- All occupants of my vehicle will be registered on any waiver or agreement if required at each individual event or trail ride, or as required by a specific event.
- I have valid liability insurance on my vehicle, and proof of insurance and current vehicle registration will be provided to DeJA event officials if requested, or to officers of a specific event or location if required.
- No occupants in my vehicle will consume alcohol while on the trails. Violation of this rule is cause for immediate expulsion from the club.
- No occupants of my vehicle will carry explosives, firearms, or sirens on the trail.
- I, as the driver, am responsible for the occupants of my vehicle.
- I understand that DeJA, its officers or members cannot be held responsible for any damage that may occur to my vehicle, my person, or my passengers while attending a club event or trail ride.
- I agree that I can be held liable for any damage caused by me or my passengers, while in my vehicle or otherwise, if damage is a result of violating the rules and guidelines of an event or trail ride.
- I agree to abide by the rules, guidance, and instruction of the appointed trail guide on a trail ride.
- I agree to abide by the principles of Tread Lightly!TM
- I understand that DeJA, per the By-Laws of the club, may amend this Agreement at any time.
- I understand that violation of these rules could result in immediate expulsion from the club, removal from the club Member roster, termination of both my own and my passengers participation in an event or trail ride, and forfeiture of any fees or costs of the event or trail ride.
- If attending a trail ride, my vehicle is equipped with the following mandatory equipment, based on requirements of off-road parks:
 - o Front and rear tow points (not including trailer balls)
 - o Fire extinguisher in working order
 - First aid kit
 - o Full size spare; adequate tread on tires
 - Seat belts for every passenger
 - No snow plows or brackets
 - No obvious hazards or problems
 - o Battery tie down
 - o Trash bags (to use for trash or liquid spills)
- I understand that the following equipment is not mandatory, but <u>highly recommended</u> for trail rides:
 - o CB radio, either hard mounted or handheld
 - o Tow strap; 20,000 lb minimum rating; no hooks (MUST have at least one in each designated group on a trail ride; per park requirements).
